Unfortunately, due to the ongoing pandemic we will be holding this meeting virtually via Zoom video conference, just as we did in 2020. The meeting will be Monday, May 10<sup>th</sup> at 7pm. A formal notice of this meeting will be sent out a couple weeks prior, including the Zoom code to use in order to be part of this meeting. ## 2020 HOMEOWNERS ASSOCIATION DUES

On January 18, 2021, the ARHA Board of Directors voted to set the annual association dues at \$135.00 for 2021 with an early payment incentive reducing dues to \$125.00 if payment is postmarked on or before June 1, 2021. The annual dues invoice will be mailed to homeowners in April. Annual dues are used to pay for such expenses as neighborhood maintenance, website fees, insurance, legal expenses, social events, and miscellaneous expenses to make sure our neighborhood remains a great place to live. The Autumn Ridge HOA remains in great financial position, and we have not had to raise dues in several years. We are looking at opportunities we will have in the upcoming years to continue to make the neighborhood the best possible place to live in Omaha.

With many of us converting from office employees to work from home employees, we just simply are not leaving our homes as much. As such, the City of Omaha has become more proactive in removing vehicles that are disabled or simply have not moved. All vehicles parked on the street MUST be moved every 48 hours, per City Code.

# COVENANTS

It's a good time for a friendly reminder about our covenants. Please remember that storage of trash receptacles on driveways, except on your assigned trash collection day, is not permitted per Omaha Municipal Code and per Autumn Ridge Covenants Article I.9. We ask that you please move your trash can(s) to a location where they cannot be seen from the street. Additionally, our covenants do not permit boats, trailers, campers, etc. to be stored in driveways and there are provisions covering swimming pools, signs, car repairs, junk, rubbish, roofing materials, etc. You can find further information at our website www.myautumnridge.com.

Specifically, we saw a number of pools being built this past year, which is awesome. A couple things to remember with pools, is that our covenants prohibit above ground pools of any kind, and in ground pools must not rise more than 12 inches above the ground. As always, we ask that you contact the board before making any improvements to make sure they work within the covenants.

If the board observes instances where our covenants are not being followed, we will make contact with the homeowner by mail, citing the covenant section, and request that action be taken to conform. Please understand, that one of our primary directives is to enforce the covenants to keep the neighborhood looking and feeling the way we want it to be. We appreciate your understanding of the role the board plays in this, and thank you for working with us.

# TRASH COLLECTION

2020 brought a new trash collection process and a new vendor for this service. The new automated trucks look great and work great. We got off to a bit of a shaky start, but things have really improved since that 1<sup>st</sup> week of collections. Some things to remember.
